Dr. Curtis welcomed the NC Federation to the Prestage Department of Poultry Science, Vision Research Outreach to ask industry for their responses to each of the commodities presentations. Goal for this meeting is to: Gain the industry input and

- 1. Make sure we are moving in the right direction.
- 2. Determine the next step in the process.

Faculty presentations followed:

Dr. Ferket – Chicken Education Unit
 Dean Linton asked for clarification on the faculty positions. Dr. Ferket is asking the
 industry how they would prioritize the list of positions? Also, how does it fit with the
 Animal Initiative, college and department?

Industry question: Eric Gonder asked for clarification about the Poultry Products System Analysts position (Big Data Management application). Bob Ford asked Dr. Ferket if it would have to be contracted out?

Dean Linton answered that CALS has partnerships with Oracle and SAS and expressed that there is a need for help from the industry to work with SAS.

2. Dr. Grimes – Talley Turkey Education Unit

Industry Question: Bob Ford asked about the water & sewer at the Lake Wheeler property.

Dean Linton answered that there is a study being done to upgrade the wells & sewer. We should hear back from the study by September or October.

3. Dr. Petitte – Layers & Research Facilities

Industry Feedback: Yes on automation. Suggestion was made that there is a need to teach students about animal welfare inspections. The Braswell Endowed Egg position has just been approved.

4. Dr. Fahrenholz – Feed Milling Program

Industry Feedback: Sherry McComas – we need teaching facility. Another industry comment was that they need Feed Mill Managers. Industry is open to collaboration. The internships were discussed, also.

5. Dr. Matthew Livingston – Poultry Processing

Industry Feedback: Bob Ford asked, how do you define cultured meat? Dr. Livingston answered, don't know, yet. We want to be the one doing the processing. Bob added that it is a controversial subject today. Industry also expressed a need for someone to work on automation robotics.

Dean Linton mentioned – Value Added Innovation Center

We need the industry to push for the facility. Bob Ford wanted to know where it would be built, Lake Wheeler or Mid Pines. Dean Linton answered that it is up to the administration.

6. Dr. Oviedo – Hatchery & Incubation Center

This Center will be created with a consortium of poultry and allied industry companies and NC State University.

Industry Feedback: Place to have training and research.

7. Dr. Koci – BSL2 Lab Facilities

Industry Feedback: Eric Gonder asked, how many BSL2 are around the country? There are 3 in Georgia and none for poultry in North Carolina. What diseases have you been asked to study that you can't because of no facility? Listeria is one. Dr. Koci will compile a list of diseases that he has been asked to research.

8. Dr. Ashwell – animal facilities on campus – bird wing (Scott Hall)

The HVAC was installed backwards in Scott Hall.

Industry Feedback: Bob Ford said that the students need a double major, one in Poultry Science and one in HVAC (they could work anywhere). Eric Gonder commented the HVAC needs to be fixed.

 Dr. Beckstead – Scott Hall Linchpin – Building looks good, however, it was designed on a high school level. HVAC installed backwards.
 Industry Feedback: Eric Gonder asked how accessible is it for students to get to Lake Wheeler. Answer: The university doesn't schedule a bus to go to Lake Wheeler.

Final comments: CEO Butterball, Neal Walsh – industry needs to work together.

Dean Linton – Animal Food Initiative is critical to move forward. CALS and CVM relationship is now building trust. Dr. Curtis is the biggest leader and is the biggest fighter in CALS. (Her nickname is Wonder Woman).

Sam Brake – We need to attract students to feed the world.

Bob Ford – Closed the meeting, thanked everyone for coming, and closed with this comment: In 2050, it is predicted that there will be 10 billion people on this planet. We need to make plans now to feed them.
